## **PROCEDURES FOR GUEST PLAYERS**

Further to the Circular No.006/2018 dt. 21.04.2018 following amendments are made for Guest Players Procedures to be followed with immediate effect.

- (a) An Government Institution / Private Corporate can appoint **Two Guest players** in All India Level Tournament by producing proper documents (Requisition in Letter Head & NOC). The player has no tenure of playing.
- (b) An Government Institution / Private Corporate can appoint Three Guest players in State Level Tournament by producing proper documents (Requisition in Letter Head with Authorised Signature, NOC & Undertaking). The player is limited to period of one year tenure (State Championship to State Championship) of playing.
- (c) If a registered Guest Player gets an valid appointment, New Guest Player can be registered intimating TNBA 15 days prior to represent any Tournament.

- (d) An Government Institution / Private Corporate must pay a minimum amount as stated below every month for the period he has been registered as Guest Player.
  - ❖ Guest Player who have represented Tamilnadu Senior Team have to be paid a minimum amount of Rs.8000/- or higher
  - ❖ Guest Player who have represented Tamilnadu Junior Team have to be paid a minimum amount of Rs.5000/- or higher
  - ❖ Guest Player who have represented All India University have to be paid a minimum amount of Rs.4000/- or higher
  - Proper shoe & uniforms to be provided
  - ❖ Travelling Expenses should be covered. In case of injury total medical expenses should be borne by them.
- (e) In case of appointment, the Guest Player has to be relieved immediately with an intimation to Tamilnadu Basketball Association with Appointment Order.
- (f) Above amendments are made keeping in mind players benefit & economical growth.
